Club awards - best clubman and club spirit, KL sending info, requesting nominations and sending poll for votes

Life members - Dave Townsend to talk to life members committee for nominations

Best & Fairest Count - Date not set, considering 17/9

Celebrations after women's grand final - Liquor permit being organised for 28/8, bus for players, bar staff and food to be organised, strongly encourage men to attend

End of year celebrations - Sat 10/9 bus for players, second bus for supporters and return to clubrooms afterwards, Sun 11/9 breakfast at the bottom pub, clubrooms during the day, top pub for dinner. Mon 12/9 Longley in the morning and Fun Bus picking up at midday.

Women's 'SFL' game - Proposed game against Claremont (Div1) prior to men's grand final games on 10/9

Salary Cap - Proposed salary cap from SFL discussed; \$65,000 for senior and reserve players, \$30,000 for senior coaches, travel allowance and declare 50% only of payment for players over 30. Majority of committee agree with \$95,000 for players and coaches but would like reserves coach included in cap, not supportive of 50% declared for players over 30.
